PRIVACY POLICY

This Privacy Policy describes how your personal information is collected, used, and shared when you visit or submit a contact from www.komodo-consulting.pt (described as the "Site").

PERSONAL INFORMATION WE COLLECT

When you visit www.komodo-consulting.pt, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse www.komodo-consulting.pt, we collect information about the individual web pages that you view, what websites or search terms referred you to www.komodo-consulting.pt, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit http://www.allaboutcookies.org;
- "Log files" track actions occurring on www.komodo-consulting.pt, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps;
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Additionally, when you submit a contact form on www.komodo-consulting.pt, we collect certain information from you, including your name, company/organisation, email address, and phone number. We refer to this information as "Contact."

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information and Forms Information.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Form's Information that we collect generally to fulfil any contact, job request or to receive our content placed through the Site. Additionally, we use this Forms Information to:

- Communicate with you by phone, email and others;
- When in line with the preferences you have shared with us, provide you with information or advertising relating to our services.

We use the Device Information that we collect to help us screen for potential spam, phishing, or virus (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our visitors browse and interact with the Site, and to assess the success of our marketing and advertising campaigns). Also, we use your Device Information in terms of the advertising (retargeting) in order to be able to show specific ads to you, only Komodo Consulting related communication and not other product or services not related with Komodo Consulting (only for Komodo Consulting proposes).

SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above. For example:
